**1. GENERAL**

**1.1 Exhibition Management**

**1.2 Agreement**

**2. ALTERATION OR CANCELLATION**

**2.1 Cancellation by participant**

Once the participant has submitted a binding booking form, they cannot be discharged from their contractual duties.

The following refunds will apply from the date of receipt of notification:

On or before 22 December 2016 (90 days out): 75% refund

On or before 20 January 2017 (60 days out): 50% refund

After 20 January 2017: No refund available

Although no refund will be made after 20 January 2017, an alternative delegate name may be provided in writing and the booking and funds will be allocated accordingly. A \$50 (USD) cancellation fee will be deducted from conference registration refunds. Registration payments made via credit card will be refunded to the original credit card and will be processed two to four weeks.

Please note no refund or discount will be made if an inclusive function or event within the registration fee is not taken up or is subsequently cancelled.

Where there is extenuating circumstances a refund outside of these terms may be considered by and at the discretion of the Organising Committee.

**2.2 Alteration or cancellation by the exhibition management**

INOVASYON reserves the right to alter or cancel, without prior notice, any of the arrangements relating directly or indirectly to the EURIE Summit, for any circumstances beyond INOVASYON's reasonable control. This includes the cancellation of the summit. INOVASYON will not accept liability for any losses and/or damages participant may suffer on account of any alteration or cancellation.
